- _____ Proof of Incidental Music Permission (**NOTE: Competing groups may not perform without permission from the appropriate licensing agent(s) to use any incidental music not in the public domain.**)
- _____ Insurance Certificate (**NOTE: Competing groups may not perform without a Certificate of Insurance in the amount of \$1 million covering April 4, 5, 6 2003 and naming the following as additional insureds: Voorhees Middle School, Voorhees Board of Education, Voorhees CER, Voorhees Theatre Company and New Jersey Theatre League**)
